## Healthcare in Action (HIA)

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

Molina holds a capitated contract agreement with Healthcare in Action effective 01/01/2022 for Primary Care Provider (PCP) and Behavioral Health Services.

In addition, Molina holds a California Advancing and Innovating Medi-Cal initiative (CALAIM) Agreement with Healthcare in Action which is effective 01/01/2022. Healthcare in Action is contracted Directly with Molina and is using Specialist from Molinas direct network to see patients.

Healthcare in Action is a non-profit organization that delivers comprehensive care to **individuals experiencing homelessness**. Using an interdisciplinary, street medicine team and medically equipped vans, HIA can meet the patient where they truly are.

**Medical services** include full-scope primary care, urgent care, chronic disease management, and mild-to-moderate outpatient behavioral and substance use disorder services. **Non-medical services** include care coordination, housing navigation, benefits enrollment, ensuring food/medically appropriate meals, appointment scheduling, transportation/accompanying to appointments, and other emotional/social support.

Providers who hold a Direct Provider agreement with Molina, do NOT have to be contracted with HealthCare in Action to render services for our members.

When verifying eligibility in Availity, the "Services Restricted to Following Provider" is only restricted to PCP and Behavioral Health services. Molina holds the risk for authorized Specialist services. Please ensure the normal authorization process is completed for services to be rendered.
