## Electronic Visit Verification Vendor and Provider Town Hall

This is an advisory notification to Molina Healthcare of California (MHC) network providers regarding Electronic Visit Verification (EVV) Vendor and Provider Town Hall.

EVV is a telephone and computer-based solution that electronically verifies in-home service visits. EVV solutions must verify the following six data elements:

- Type of service performed
- Individual receiving the service
- Date of the service
- Location of service delivery
- Individual providing the service
- Time the service begins and ends

As a reminder, all Molina Healthcare providers of Community Supports – Personal Care and Home Health Care Services (HHCS) Respite Services, and Day Habilitation Programs were to register no later than October 19, 2022 and submit proof of registration and training to their assigned Provider Services Representation as listed below.

Per the federal CURES Act, if a provider (enrolled, contracted or subcontracted) renders Medi-Cal services that are subject to EVV that provider is required to be registered, trained, using either the CalEVV system or an Alternate EVV solution, and submitting EVV visit data by no later than January 1, 2023. Otherwise, the service provider will be considered out of compliance. As a result, DHCS may take disciplinary action(s) to address the non-compliant provider.
