New Long Term Care Local Accommodation Codes

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

What you need to know:

The Department of Health Care Services (DHCS) will be implementing a transition from the current Long Term Care (LTC) local Accommodation Codes to a more comprehensive combination of National Uniform Billing Committee (NUBC) Revenue Codes, Value Codes, and Value Code Amounts specifically tailored for LTC services.

This strategic shift aims to provide a clearer and more standardized framework, ensuring a more seamless correlation between the previously used local Accommodation Codes and the corresponding NUBC codes. The intention behind this crosswalk is to facilitate a better understanding and correlation between these coding systems, ultimately enhancing the accuracy and efficiency of our services.

When this is happening:

Effective February 1, 2024.
