2024 Medi-Cal Provider Manual Updates

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

What you need to know:

The 2024 Medi-Cal Provider Manual has been updated and is available online through the Provider Molina Healthcare Website.

We will continue to make updates throughout the year to reflect new program requirements and policy changes and will communicate these changes accordingly.

Notably, covered Vision Services were transitioned from March Vision to VSP effective July 1, 2024. A provider bulletin was distributed on June 19, 2024, to inform our healthcare partners of the changes.
