Second Quarter 2023 Pharmacy Formulary Change Notice—Illinois Medicaid

Molina Healthcare of Illinois (Molina) has made the following changes to the Medicaid Preferred Drug List (PDL), **effective April 1, 2023**. What It Means For You

If you prescribe for a Molina member any of the non-preferred products that may be listed below, consider replacing it with a preferred product, if possible, on/after April 1, 2023. If a change is not possible, you should complete and submit a [Pharmacy Prior Authorization form](#), including documentation explaining why it is not possible to change to the preferred drug.
