

Notice of Changes to February 1, 2021 Prior Authorization (PA) Requirements

Information for Medicaid, MyCare Ohio Medicaid and Marketplace providers

On January 13, 2021, the updated Prior Authorization (PA) Code Lists will be posted on our website, under the “Forms” tab for a Feb. 13, 2021 effective date.

The Feb. 13, 2021 Medicaid and MyCare Ohio Medicaid PA Code List change includes:

- Unlisted/Miscellaneous Codes: Addition of a Feb. 13, 2021 effective date for G0483 to require PA

The Feb. 13, 2021 Marketplace PA Code List changes include:

- Behavioral Health, Mental Health, Alcohol & Chemical Dependency Services: Addition of multiple codes requiring a PA after a specified number of units have been used in any combination

Note: All codes from the Jan. 1, 2021 PA Code List and the Feb. 1, 2021 PA Code List are included on the Feb. 13, 2021 PA Code List. All three lists will be available on our website for ease of reference. For reference:
